Overnight cost is based on per pair of lodges with a total of 88 people. Usage of all four lodges would double the night costs with a total of 176 beds.

Elm Lodge (29 beds) overnight cost is based on the costs above.

The above prices include the use of the following facilities: Refrigeration and ice, the indoor chapel (if available), the outdoor chapel, the recreation hall, playground equipment, and the campfire circle. Meals can be provided by camp staff or by self. ***Cold meal prep is included; however, a kitchen use fee of \$80 per meal will apply with the use of any cooking appliances.***

The minimum charge for meals will be the number you communicate to the Site Director two weeks before your scheduled arrival. Guests dining in excess of the number indicated will be billed at the current rates.

DEPOSITS

For the *LODGES*, a deposit of \$319.00 must accompany the completed reservation form. For the *RETREAT CABIN*, a deposit fee of \$63.00 must accompany the completed reservation form. *DAY USE RESERVATIONS* must be paid in full at the time the reservation is placed. Completed reservation form and deposit must be received in the Camping Office within 15 days of initial reservation request. If the deposit is not received in that period of time, another group may make a reservation for that facility.

DISCOUNT POLICY

Church groups from the Central Pennsylvania Conference of the United Methodist Church, who have paid their Shares of Ministry in full in the previous year, are eligible for a 10% discount on lodging or facility rental. Agencies of CPCUMC are also eligible for a 10% discount on lodging or facility rental. This discount will be reflected on the invoice for the event.

REFUND POLICY

Deposits are refundable (minus a \$50.00 processing fee) when cancellations are received 90 days prior to the scheduled arrival. Cancellations received less than 90 days prior to the event will result in the forfeiture of the full deposit. If the cancellation is received less than 45 days prior to the event, your group will be billed for one half the total cost of the event, minus your deposit.

DAMAGE POLICY

All damages (including graffiti) will be assessed and billed to the group at the rate of cost of repair and/or replacement.

INSURANCE

Incorporated groups not related to the Central Pennsylvania Conference of The United Methodist Church are required to submit a *Certificate of Insurance* to the Camping Office prior to their arrival at the site. Non-incorporated groups are hereby notified that any individual claim for accidents, illness or dental is the sole responsibility of the individual, and will need to be submitted for payment to his/her personal health insurance.
